The general partners of the limited partnership shall deliver to the Greffier evidence acceptable to the Greffier that the removal of the limited partnership from the Register is not prohibited by Regulation 15 paragraph (1) of The Limited Partnerships (Guernsey) (Migration) Regulations, 2020 and upon receipt thereof the Greffier shall give notice of the proposed removal from the Register.
